Background of event

The European Commission has recently published the Guidance for Member States on the selection of bodies implementing financial instruments under European Structural and Investment Funds (ESIF). The guidance provides clarifications about the procedures for selecting bodies to whom the managing authorities may entrust the financial instruments implementation tasks as foreseen in Article 38(4) (b) of the Common Provisions Regulation. Managing authorities need to comply with all applicable laws, including public procurement, when selecting these bodies.



fi-compass is organising an event that aims to:

- Accommodate the need of *fi-compass* stakeholders for guidance on the rules for selection of bodies implementing financial instruments under ESIF;
- Enable participants to understand the implications and opportunities of the recently adopted EC Regulatory Guidance on selection of bodies implementing financial instruments under ESIF and to apply the legal provisions in practice; and
