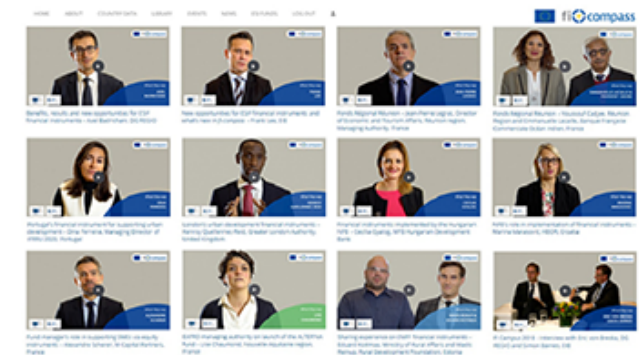
fi-compass Showcase 2019 – Promoting ESIF financial instruments stories across the EU
