# The context in Estonia

2013

- We have a problem: land of Start-Up's, but no local capital
  - Lack of track record in VC
  - Lack of local VC
  - Loss of future tax revenue
- Ideas from the Marketplace
  - Do a Fund of Funds!
- Solution via EIF

#### 2015

- We still have a problem
  - Almost all VC still foreign
  - Acknowledged market failures
  - Angels rising!
  - The market raises a voice ...

... but we're getting closer via FI! 🙂



#### The context in EU

2013

- More FI via ESI Funds!
- Setting MS-specific strategies

... setting the stage for good FI policies

2015


- A toolbox to be used
  - FI-Compass 🙂
  - REGULATION (EU) No 1303/2013
  - REGULATION (EU) No 480/2014
  - Local ESIF regulations
  - Etc.

... enabling good FI policies



# Finding a solution

- Good practice available
  - Baltic Innovation Fund
    - Fund of Funds
  - EIF as a cornerstone
- A call for something more
  - Analysis of Market Failures = ex ante
    - Lack of finance
    - Lack of information
    - Lack of professional Fund managers
  - Result: Estonian Early Stage Fund of Funds
    60 M EUR of ESI Funds (ERDF) + private sector






# **Building a solution**

- No MS experience in building FI via ESIF
  - What kind of contracts?
  - Who does what and when?
  - The devils are in the details ...
    - ... but let's just do it!

- Help from EIF
- Experience in FI





#### **Lessons learned**

- Ex ante assessment is good for you! process innovation in public sector ③ an assessment of your "health" a bystander's view of the world
- You need local expertise as well as foreign quality!
- Listen to *your* market!
- Be creative ... as much as you can  $\ensuremath{\mathfrak{O}}$



# Going forward via FI

- 28.05.2015
  - Decision by Government to invest 60 M EUR
- Summer 2015
  - Contract between Estonia and EIF
- Late 2015
  - Operations begin!
- 2017-2018
  - Renew ex ante, check course
